Waterville Central School District COVID-19 Plan: Layered Mitigation Protocols August 24, 2021

Dear Waterville CSD family,

On behalf of the Board of Education, faculty and staff of the Waterville CSD, I welcome you to the 2021-22 school year! We are excited to have all of our students back in school this year for a full day of in-person instruction. While there is still uncertainty related to COVID-19, please know the district is committed to ensuring a safe and healthy learning environment for all students, faculty and staff. Based on the current COVID transmission rate in Oneida County and recommendations from the Centers for Disease Control (CDC), the American Academy of Pediatrics (AAP) and The New York State Education Department, we have developed the following procedures and health and safety protocols that will be in place when students return for the first day of school on September 7.

- Instruction will be fully in-person.
- Masks will be mandatory in all schools and district buildings regardless of vaccination status. Masks will be optional outside on school grounds.
- Masks will be required on school buses. We will be returning to full capacity transport this school year.
- A 3-feet physical distance requirement will be in place in our school buildings, including classrooms. Students in band and choir will be distanced at 6'.
- While eating in the cafeteria, students will be distanced 6' apart.
- If a student tests positive, the close contacts of the student from the classroom will not be expected to quarantine as long as a 3-6 foot distance was maintained and masks were worn consistently and properly the entire time, as long as the student remains symptom free.
- Individual students who are directed to quarantine by the OCHD will be provided packets, online documents or assigned work to complete at home. An online tutor will be available. There will not be an option to join their class remotely unless more than 50% of the class is required to quarantine.
- Unvaccinated adults who are considered close contacts of an individual with a suspected or confirmed COVID diagnosis may be expected to quarantine for 10-days, as per the review of the case by the Oneida County Health Department.
- We will not be conducting health screenings but urge those who are experiencing COVID-19 symptoms, to stay home and get tested.
- Hand hygiene, and daily cleaning and disinfecting protocols will continue to be practiced to ensure a safe and healthy environment.
- The fall athletic season began August 23. Athletes are required to wear masks while indoors.

We strongly encourage all who are eligible for a COVID-19 vaccination to get one. We will continue to coordinate vaccination clinics this school year. While this still remains a time of uncertainty, I am extremely confident that the 2021-22 school year will be a successful one. Thank you for your continued partnership. It is our privilege to educate your children.
