SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. A comprehensive, strategic and collaborative process was utilized to determine the best use of these funds to address student needs. The Superintendent met with the Board of Education, administrators, parents and faculty - representing the teacher's association, data coordinator, and title one coordinator - to formulate a strategic plan to identify the district's needs through a SWOT analysis. This collaborative review was an opportunity for the team to establish the District's new vision, mission, beliefs and commitment statements based on a focus for the future. A survey, highlighting the new framework, was pushed out to staff, parents and the community for feedback. Once the district's framework was finalized, priorities were established, and shared with all parties for additional feedback. District committees - technology, health and wellness, professional development and safety - created action steps to support the identified priorities. Each committee consists of board members, the superintendent, administrators, teachers, non-instructional staff and parents. These committees are charged with the oversight of the action steps and achievement of the following priorities:

Priority #1: *We will address instructional learning gaps and focus on increasing academic achievement for all students*

Priority #2: *We will implement strategies/programs/services to enhance the social/emotional/physical wellness of both students and staff.*

Priority #3: *We will enhance connections with and opportunities for post secondary success*

3. In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.

In an effort to support a layered mitigation approach (Re-opening Plan) aligned with CDC guidance, the district has partnered with a local health provider, Upstate Family Health Center, to implement a school based health center (SBHC) in both of the district's schools. The district is awaiting official approval from NYSDOH. A SBHC had long been the district's goal as each building has a completely renovated school based health center space that was approved in a 2015 capital project and completed in 2019. The district had been unsuccessful in finding a suitable partner prior to 2021. Through the partnership with Upstate Family Health, the SBHC will provide the resources for students and staff within the district that will help to reduce and mitigate the transmission of COVID-19. As a small rural community, access to health care services is extremely limited unless one makes the 30 minute drive to either Cooperstown or Utica. Direct services will include testing and tracking of unvaccinated staff, as required by the NYS Governor, onsite testing of symptomatic students or staff, assisting students with health care needs that may not be related to COVID -19 but potentially could appear to be symptoms of such. The expectation is that students receiving care in the SBHC will be identified quickly if they are positive for the virus and can be removed to prevent further spread. Likewise, students who are identified as negative and can remain in school unless they are carrying a different communicable disease. Ultimately, through the collaborative efforts with the SBHC, we expect to see a stable or decreased absenteeism rate. Parents will not need to take their child out of school to get testing done nor will parents need to wait 24 to 72 hours to obtain an appointment to get their child a COVID -19 test. These prevention strategies will continue to support the district's full reopening plan in alignment with recent CDC guidance and regulations.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

Addressing instructional learning gaps and focusing on achievement for all students is an identified district priority. The district is partnering with the Reading League to provide staff training to incorporate a pervasive, consistent and explicit approach to reading instruction K-6. As part of this, the district is assessing student reading fluency levels, the most important indicator of reading proficiency, through the use of a School-Wide Screening tool. The DIBELS 8th edition is administered to students three times per year. Cut scores are established that identify students who are performing at benchmark, at risk, or seriously at risk levels. Students considered "at risk" will have follow up monitoring and screening through a multi-tier service delivery model. Each tier provides increasing levels of intensity of services that match the needs of the students. AIS/ RTI teachers use DIBELS 8th edition to progress monitor Tier 2 and Tier 3 students. Data from progress monitoring is used to inform students movement through the tiers.

Additionally, students are regularly assessed through iReady, the district's progress monitoring platform, to assess all aspects of a student's reading performance as well as math proficiency. District K-8 teachers will engage in iReady professional development to enhance their knowledge of diagnostics to better identify student gaps, monitor their progress and apply appropriate interventions. Once teachers have examined data regarding a student's needs, teachers will work collaboratively to plan interventions and monitor the success of these supports. The district is also conducting a review of its AIS and RTi interventions to ensure high-functioning processes and outcomes that support student growth.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

The district worked collaboratively to implement a comprehensive approach to addressing the impact of lost instructional time. One identified need was to utilize funds to support an in-person STEAM summer learning program for students in grades K-5 during the summer of 2021-2022. This program, attended by 25% of the student population, was focused on hands-on, high-interest STEAM learning experiences, designed to maximize the outdoors. Highlights of the program included integrated learning with a number of local partners: Cornell Cooperative Extension, BOCES Science Kits, the Utica Zoo and the NYS Park Service. The program will expand to eighth grade next summer and include a focus on agriculture to take advantage of the district's new greenhouse. Parents were very clear that they wanted their children to benefit from additional instructional time to make up for hybrid and virtual learning during the pandemic. The Waterville Teachers Association overwhelmingly approved a 30 minute extension of the instructional day beginning in 2021-22 and continuing through 2023-2024. The extended day program includes an additional thirty minutes a day for every student K-12, totaling 90 additional hours of direct face-to-face instruction with Waterville teachers. Funds are being designated from ARP-ESSER2 to accomplish the extended day goals.

The District will be using additional funds to invest in and support high quality teaching. Teachers and administrators will engage in cultivating emotional resilience through a district-wide book study led by the superintendent. Staff members were given a copy of *Onward: Cultivating Emotional Resilience in Educators* as a way to foster greater awareness of resilience, self-care and emotional healing. Key topics are integrated into monthly faculty meetings allowing staff time to collaborate, reflect and grow. Additionally, the district is strengthening curriculum alignment through the use of the Atlas curriculum mapping software. All K-12 teachers are mapping course instructional calendars and formalizing unit planning aligned with standards. Teachers are also collaborating with colleagues to ensure vertical and horizontal alignment. This will allow the district to ensure a guaranteed and viable curriculum aligned with standards and assessments.

7. The District is committed to promoting a positive and supportive school culture, especially as we welcome all students back to full day in-person learning. With the extra time in the school day, teachers are now able to integrate social emotional wellness into classroom instructional learning experiences. Through the Positivity Project and with the help of building P2 coordinators, teachers in grades K-6 are integrating the 24 character traits into daily instruction for 15 minutes each day. Students are learning to recognize their feelings and being mindful of how they treat others. The principal is leading Mindful Mondays as a way to promote a calm and resilient atmosphere in the building. At the Jr/Sr High, the 24 character traits are incorporated into Physical Education instruction so that all students are immersed and engaged in the vocabulary and corresponding lessons designed to promote greater empathy and caring for others. To gain a better understanding of school culture, the District will be administering, for the first time, the US Department of Education's School Climate Survey to students, parents, and staff.
