## **Budget vote, board elections** scheduled for May 20

On Tuesday, May 20, Waterville Central School District residents will vote on a proposed \$23,127,669 spending plan for the 2025-26 school year. The proposed budget was thoughtfully developed to support the district's educational mission and meet the needs of all students — while remaining fiscally responsible to the community.

The budget proposal includes a 2.00% increase in the tax levy, which is consistent with prior year budgets. The tax levy reflects the portion of funding the district seeks to collect through local property taxes to help balance the overall budget.

Due to a limited Foundation Aid increase this year, the district is making targeted spending adjustments to address rising costs in programmatic services, employee benefits and operational expenses. The district will apply fund balance strategically to close remaining budget gaps.

#### **Key Budget Drivers for 2025-26 RISING COSTS**

- Health insurance premiums to increase by 12%.
- Contributions to state retirement systems to rise by 8%.
- Costs previously covered by pandemic relief funds shifted to the general fund.

#### SALARY OBLIGATIONS

- Contractual salary increases for Waterville Teachers Association members.
- Salary increases for SEIU-represented non-instructional staff.

#### ADDITIONAL BUDGET PRESSURES

- Increased costs for special education placements.
- Higher liability insurance premiums.

The budget also includes a \$100,000 capital outlay project to fund replacing doors at Memorial Park Elementary School.

The budget includes a proposal on the ballot for the purchase of two large school buses, one small school bus, and one pickup truck with a dump body and plow, all at an estimated maximum aggregate cost of \$602,000.

#### LIBRARY

The ballot includes a proposition that, if approved, would authorize the district to levy and collect a tax in the amount of \$266,950 for the Waterville Public Library and \$104,205 for the C.W. Clark Memorial Library.

One person, Corrine Bishopp, is running for one of three open seats on the Waterville Public Library Board of Trustees.



## **Absentee Ballots**

Both absentee ballot and early voting are available. You must fill out an application to vote by early voting or absentee ballot. There are separate applications for each, but the application process and deadlines are the same for both. Early mail voting is similar to absentee voting, but requires no reason as to why in-person voting is not possible. The voter must indicate only that they are qualified and wish to vote early by mail.

The completed ballot must be received by 5 p.m. on May 20, 2025 (the day of the vote).
